The foregoing table is intended to highlight only some important aspects of coverage and is not to be construed as expanding or limited the coverage as set forth in the before mentioned policies, Copies of these policies are available upon request. Decisions on coverage should be made only after review of the policies themselves.</i>		

*Note: The Eagle/Homeowners Policies also contain a provision that allows for the Policy Amount to increase by ten percent (10%) of the Policy Amount shown in Schedule A each year for the first five years following the policy date shown in Schedule A, up to one hundred fifty percent (150%) of the Policy Amount on the Anniversary of the Policy Date.*
